The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be **ARTS TRIUMPHANT CONSERVATORY, INC.**

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation with the Secretary of State of Florida. This corporation's duration shall be perpetual.

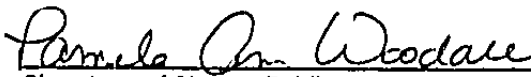
