The undersigned hereby associate themselves for the purpose of the becoming a body corporate under the Laws of the State of Florida and do hereby certify, make, subscribe, acknowledge and file, in the Office of the Department of State, this certificate:

- 1. The name of the corporation shall be: BLANCHARD & BLANCHARD, INC..
- 2. The general nature of the business to be transacted is as follows:

Exterior and interior general lawn service and landscaping.

To manufacture, purchase or otherwise acquire, own, mortgage, pledge, sell, assign and transfer or otherwise dispose of, to invest, trade, deal in and with goods, wares and merchandise, and real and personal property of every class and description.
