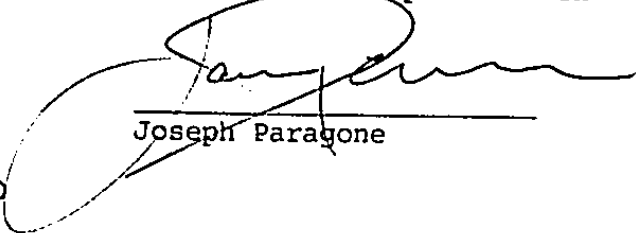
ARTICLE VII: DIRECTORS

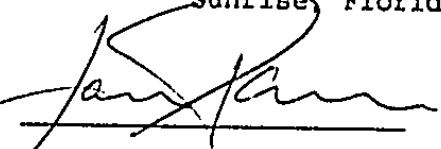

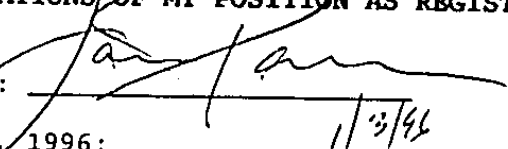
