The undersigned incorporator, for the purpose of forming a Florida corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLES I - Name

The name of the corporation is MM Yogurt, Inc. (hereinafter called the "Corporation").

ARTICLE II - Mailing Address

The mailing address of the Corporation is 5233 N.E. 20th Avenue, Pompano Beach, Florida 33064.

ARTICLE III - Capital Stock

The number of shares of capital stock that the Corporation is authorized to issue is One Thousand (1,000) shares, \$0.01 par value per share, of common stock. Each issued and outstanding share of common stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.


**CERTIFICATE OF ACCEPTANCE BY
