
I recently returned from an extended trip out of state. Among the mail was a 2002 Uniform Business Report requesting a \$550 fee. Upon inquiry, our accountant told me that this was due to the fact that I did not send the required report prior to May 1 with the \$150. On further investigation, I discovered the reason.

I moved my home from 257 Barbados Drive, Jupiter, FL, to 188 Hampton Circle, Jupiter, FL, during January. There must have been a problem with mail forwarding because I never received the original report that would have been due May 1. Apparently, the postal service eventually provided the state with my new Hampton Circle address. During the process of trying to resolve the first problem, a reinstatement report arrived from the state.

It is unfortunate that it is the receipt of the report that prompts payment for an average person like myself. Without receiving the report, I am not reminded that there is a report due on an infrequent annual basis.

I am requesting, at this time, that the state please abate the reinstatement charges and allow the corporation to renew at the \$150 per year rate. I have noted the new address in box 2, 3 and 12. I have enclosed a check for the \$150 filing fee.
