# ARTICLES OF INCORPORATION OF CLEMONS TRUCKING CO.

The undersigned, for the purpose of ferming a corporation under the Fierida General Act hereby adopt the following Articles of Incorporation.

# ARTICLE 1

# Name

The name of the Corporation shall be: CLEMONS TRUCKING CO..

# ARTICLE II

#### Nature of Business

The general nature of the business and the objects and purposes to be transacted and carried on are: To do any and all legal business allowed by the laws of the State of Florida and of the United States.

#### ARTICLE III


