ARTICLES OF INCORPORATION

Article 1. Name. The name of the Corporation is Dare to Dream, Inc.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The purpose of the corporation is as follows:

A. This is a for profit corporation organized for the purpose of carrying out legal business in the state of Florida as permitted by Federal and State Statutes.

B. To provide services in the areas:

- I. Mental Health Management and Education.
- II. Case management, consulting, and supports coordination.
- III. Research, development, and marketing of products and services.

C. To exercise all rights and powers conferred by the laws of the State of Florida upon corporations.

Article 4. Share Holders. The corporation shall have Share Holders who will own stock in the corporation. Each Share Holder will be a fully vested voting member of the corporation. Each Share Holder will be entitled to one vote per share of stock they own. The Share Holders are entitled to vote on all issues concerning the corporation, including the election of a Board of Directors, adoption of initial Bylaws, review and amendment of subsequent Bylaws, and the appointment of a Registered Agent and Office. Article 5. Initial Registered Agent and Office. The initial Registered Agent is Oscar G. Sansoni, and the initial registered office 13621 Marsh Harbor Place, Tampa, Florida.

Article 6. Initial Board of Directors. The Initial Board of Directors shall be elected by the Share Holders. The Board of Directors will have the delegated powers to run the administration of the corporation, create Bylaws, set policies, and appoint Officers of the corporation in accord with the Bylaws and policies of the corporation. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws. Article 9. Stock. This is a closed Corporation with 10,000 shares of no par value stock.

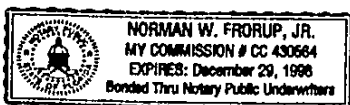
