on may 3, 2000, my younger brother committed suicide. it was a complete shock to my entire family, and it affected me in ways i can never fully explain. i have had periods when i also battled with depression, and the death of my brother only served to ad to my own feelings of self-doubt. suffice it to say that the anniversary of that horrible event was quite distracting. the days leading up to may 3rd were difficilt for me, and my depression during jan and feb was an almost daily affair. peaks and valleys, so to speak.

when i recieved the UBR from my accountant, i set it aside because, quite frankly, we didn't have the funds to pay it immediately. alas, it became lost in the shuffle, and my attention to details suffered as i counted down the days with may 3rd looming large on the horizen. the month of feb was particularly difficult, and it became harder and harder for me to focus on the task at hand; running my business. the fact that i had forgotten to file the UBR paled in comparison to the personal battle i was fighting. acl to the mix that my brother's birthday was may 20, and the month of may has been a long, long month.

it is time to move on. i have tried very hard to not allow my life to be defined by a date on the calendar. getting through this first anniversary was tough, but the passage of time will hopefully ease the grief i feel.

it is for these reasons that i therefore request leniency on the filing deadline. i am sending the original filing fee, and sincerely hope this explanation will be sufficent. if the penalty is still to be applied, i also request a deferred payment schedule. your understanding in this matter will be greatly appreciated.
