The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of this corporation shall be **E.D. DAVIS, M.D., P.A.**

**ARTICLE II**

The corporation may engage in the practice of medicine in the State of Florida. Further, the corporation may perform such other necessary and reasonable acts in any manner associated with the practice of medicine. The corporation may also engage in any other activity permitted under Chapter 621, Florida Statutes.

**ARTICLE III**

The capital stock of this corporation shall consist of 100 shares of common stock. The common stock shall not carry a par value and each share shall be entitled to one vote. Consideration to be paid for each shall be payable in lawful money of the United States or any property, labor or services at just valuation to be fixed by the stockholders. Stock shall be subject to pre-emptive rights.

**ARTICLE IV**

The amount of capital with which this corporation will begin business is \$100.00.

**ARTICLE V**

This corporation is to exist perpetually.

#### **ARTICLE VI**

The initial street address of the principal office of this corporation in the State of Florida is 330 North Clyde Morris Boulevard, Daytona Beach, Florida 32114.
