Such amendment is as follows:

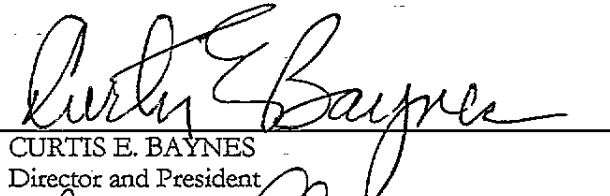
ARTICLE IV

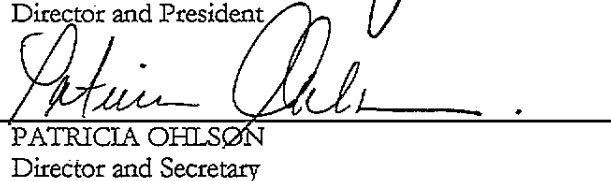
The corporation shall have the authority to issue one million (1,000,000) shares of common stock having a par value of \$1.00 per share.

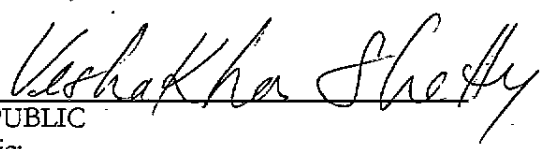
