ARTICLES OF INCORPORATION  
OF

LI REALTY, INC.

**ARTICLE I - CORPORATE NAME:**

The name of the corporation is Li Realty, Inc.

**ARTICLE II - NATURE OF BUSINESS AND POWERS:**

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III - CAPITAL STOCK:**

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.

**ARTICLE IV - TERM OF EXISTENCE:**

This corporation shall have perpetual existence commencing upon the filing of these articles.

**ARTICLE V - INITIAL PRINCIPAL OFFICE:**

The initial principal address of this corporation in the State of Florida shall be: 3044 S. Military Trail, Lake Worth, Fla. 33463.

**ARTICLE VI - BOARD OF DIRECTORS:**

This corporation shall have one (1) director. The number of directors may be increased or diminished from time to time by by-laws adopted by the stockholders but there shall never be less than one (1) director.

**ARTICLE VII - INITIAL DIRECTOR:**

The name and address of the initial director of this corporation is: Rosemary Niner, 3044 S. Military Trail, Lake Worth, Fla. 33463.

The person named as initial director shall hold office for the first year of existence of this corporation or until her successor is elected or appointed and has qualified, whichever occurs first.

**ARTICLE VIII - INCORPORATION:**

**ARTICLE IX - AMENDMENT:**

These articles of incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these articles of incorporation be made.
