

The undersigned, Louis D Cannon, does hereby become a corporation under the Laws of The State of Florida by making, subscribing, and acknowledging and filing in the Office of the Secretary of State, the following certificate and we do hereby certify that:

ARTICLE I

The name of the corporation shall be INDUSTRIAL REPAIR SERVICES, INC.

ARTICLE II

The principal office of the Corporation shall be at 2251 N "E" St, Pensacola, Florida 32501

ARTICLE III

The maximum number of shares of stock with par value of one dollar (\$1.00) each that the corporation is authorized to have outstanding at any time is 5,000 shares.

The Corporation shall have perpetual existence.


ARTICLE VII


