# ARTICLES OF INCORPORATION

#### OF

# LAKEHAYEN UTILITY, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE 1 - NAME

The name of the corporation is LAKEHAVEN UTILITY, INC.

#### **ARTICLE II - DURATION**

The duration of the corporation is perpetual.

#### **ARTICLE III - PURPOSE**

The general purposes for which the corporation is organized are:

- (1) To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with products, goods, wares, merchandise, real and personal property and services of every kind, class and description.
- (2) To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
- (3) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

#### **ARTICLE IV - CAPITAL STOCK**

(1) The total number of shares of capital stock authorized to be issued by the corporation shall be One Hundred (100) shares having a par value of \$1.00 per share. Each of

the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in eash, in property or in labor or services at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be nonassessable.

(2) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.

# ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The initial street and mailing address of the principal office of this corporation in the State of Florida will be 500 Fedhaven Circle, Fedhaven, Florida 33854. The Board of Directors may from time to time move the principal office to any other address in Florida. The name of the initial registered agent of this corporation is MARK R. RUBIN, located at 777 Arthur Godfrey Road, Miami Beach, Florida 33140.

# ARTICLE VI - INITIAL BOARD OF DIRECTORS

This corporation shall have four (4) directors initially. The number of directors may be either increased or diminished from time to time by the bylaws but shall never be less than one. The name and address of each person who is to serve as a member of the initial Board of Directors is:
