## ARTICLES OF INCORPORATION

## MANEREDI TOWING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: MANFREDI TOWING, INC.
