The undersigned incorporator of these Articles of Incorporation of being a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida by and under the provisions of the Statutes of the Articles of the State providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I - NAME

The name of the corporation is "MOHAWK AUTO SALES, INC.", (hereinafter referred to as the "Corporation").
