ARTICLES OF INCORPORATION

OF

FEDHAYEN APARTMENTS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE 1 - NAME

The name of the corporation is FEDHAVEN APARTMENTS, INC.

ARTICLE II - DURATION

The duration of the corporation is perpetual.
