

## ARTICLE 1 - PURPOSE

## ARTICLE II - DURATION

- To have a corporate seal which may be altered at pleasure, and to use the same by causing it, or a facelmile theroof, to be impressed or affixed or in any other monner reproduced.
- To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with, real or personal property, or any interest therein, wherever situated.
- To sell, convey, mortgage, pledge, create a security interest in, leane, exchange, transfer and otherwise dispose of all or any part of its property and assets.
- To lend money and use its credit to assist its officers and employees in accordance with law.
- 7.
