ARTICLES OF INCORPORATION OF
ROBINFIELD VENTURES, INC.

ARTICLE I

Name

The name of the corporation is ROBINFIELD VENTURES, INC.

ARTICLE II

Duration

The period of existence of the corporation is perpetual.

ARTICLE III

Principal Office and Mailing Address

The principal place of business of the corporation is at 3830-7 Williamsburg Park, Jacksonville, Florida 32257. The mailing address of the corporation is the same.

ARTICLE IV

Registered Office and Registered Agent
