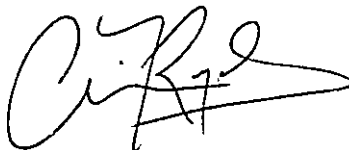

ARTICLE I NAME

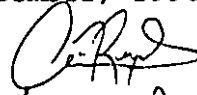

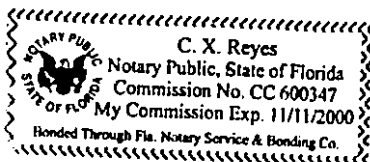
