ARTICLES OF INCORPORATION OF

'ARTICLE I - NAME

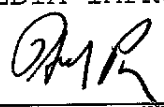
The name of this corporation shall be:

AIPS Licensing, Inc.'"

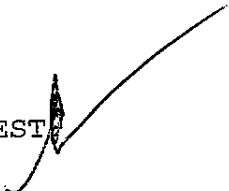
