ARTICLES OF INCORPORATION
OF
MARK RYAN NURSERY, INC.

ARTICLE I

NAME: The name of this Corporation is MARK RYAN NURSERY, INC., and its address is 142 West Oak Street, Apopka, Florida 32703.

ARTICLE II

DURATION: This Corporation shall exist perpetually.

ARTICLE III

PURPOSE: The purpose is to engage in any activities or business permitted in the laws of the United States and Florida.

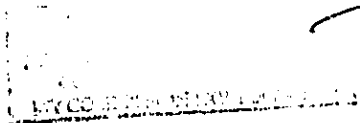
