# ARTICLES OF INCORPORATION OF SAFE LAD'S. INC.

THE UNDERSIGNED, acting as sole incorporator of SAFE LAD'S, INC. INC. Under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

#### ARTICLE 1

#### **Name**

The name of the corporation shall be SAFE LAD'S, INC.

#### ARTICLE II

#### **Shares**

The number of shares which the corporation shall have authority to issue is One Thousand (1,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

#### ARTICLE III
