

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned subscriber to these Articles of Incorporation, each a natural person, each competent to contract, hereby form a corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of the corporation is **MRX TECHNOLOGIES, INC.**

**ARTICLE II**

**NATURE OF BUSINESS**

The purpose of **MRX TECHNOLOGIES, INC.**, includes all lawful business activities set forth under Federal, State, Commonwealth, County, Parish, and local laws of the United States, and all lawful business activities set forth under the Federal, Regional, State, District, Provincial and local laws of all 178 current Countries.

- Provide the United States and all 178 Countries with financing and access to a mathematically proven, financially profitable, fully funded health care system.
- Provide the United States and all 178 Countries with financing and access to **MRX** medical facilities, providing curative therapies for most virus, bacteria, cancer, heart disease, and the top 200 terminal illnesses globally.



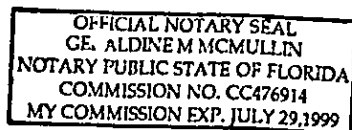


