ARTICLES OF INCORPORATION

OF

HOMESFLORIDA.COM, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE | NAME

The name of the corporation shall be HOMESFLORIDA.COM, INC.

ARTICLE II NATURE OF BUSINESS
