ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME OF INCORPORATION

The name of the Corporation is Media First Connections, Inc.

ARTICLE II

The principal office of the corporation is located at 133 Harness Lane, Kissimmee, Florida 34743.

ARTICLE III

The street address of the initial registered agent of the Corporation is 133 Harness Lane, Kissimmee, FL.

ARTICLE IV

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE V

The affairs of this Corporation shall be managed initially by a board of one (1) Director. The number of Directors may be changed by amendment of the By-laws of the Corporation. The name and address of the person who is to act in the capacity of Director until the selection of her successor is:

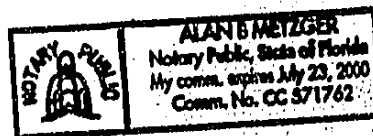
