The undersigned, all of whom are duly licensed to practice law in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act adopt the following Articles of Incorporation:

**I. NAME**

The name of the professional Corporation is KAKLIS, REID, VENABLE AND WITT, P.A.

**II. PURPOSE**

The purpose for which the Corporation is organized is to practice the profession of law.

**III. ELECTION UNDER PROFESSIONAL CORPORATION ACT**

The Corporation elects to be governed by the provisions of the Florida Professional Service Corporation and Limited Liability Company Act.

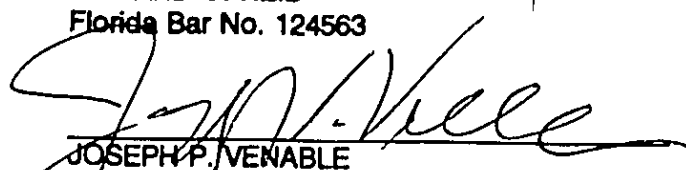

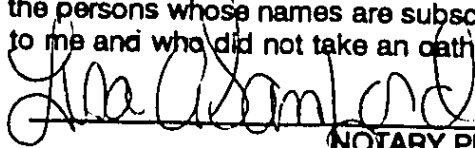

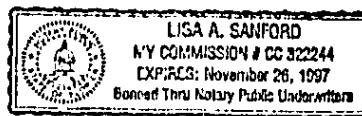
