ARTICLES OF INCORPORATION

OF

COASTAL NETWORK REALTY CORP.

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is Coastal Network Realty Corp.

SECOND: The street address, wherever located, of the principal office of the corporation is 20035 Palm Island Drive, Boca Raton, Florida 33498.

THIRD: The number of shares that the corporation is authorized to issue is One Hundred (100), each of which has a par value of \$.01 per share, all of which are of the same class and are Common shares.

NINTH: Whenever the corporation shall be engaged in the business of exploiting natural resources or other wasting assets, distributions may be paid in cash out of depletion or similar reserves at the discretion of the Board of Directors and in conformity with the provisions of the Florida Business Corporation Act,
