ARTICLE III

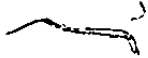
DURATION

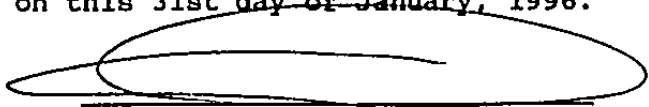

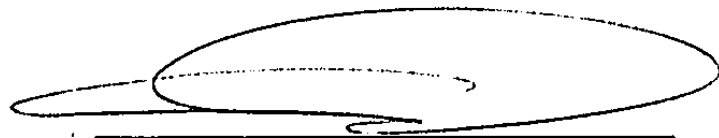
