ARTICLE I - NAME

The name of this Corporation is: CLARK ROAD COMMERCE DISTRICT ASSOCIATION, INC., A MAJOR EMPLOYMENT CENTER.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of the Corporation shall be to:

A. Advertise, promote, protect and improve the Clark Road Commerce District Association, Inc., A Major Employment Center, area on behalf of its stockholders in such a manner as may be determined by its Officers and Board of Directors and stockholders according to the terms and conditions of the Bylaws.

B. To consider and suggest ways to improve conditions and to disseminate among the stockholders any information deemed advisable.

C. To engage in any activities or business permitted under the Laws of the United States and Florida within the guidelines stated above.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$0.01 per share.

ARTICLE V - INITIAL REGISTERED

VAN WINKLE, ESQ. who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of nine members. The number of directors may be increased or decreased from time to time by vote of the Stockholders, but in no case shall the number


