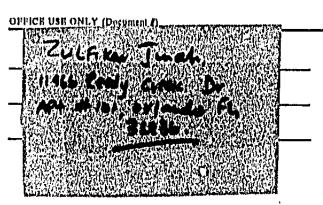

Term of Existence

Capital Structure
