ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation is a natural paraon competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The Hame of the Corporation is TRENTEX INTERNATIONAL CORPORATION (hereinafter, "Corporation").

ARTICLE 2 - PURPOSE OF CORPORATION

ARTICLE 7 - CORPORATE CAPITA' ZATION
