We, the undersigned, do hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, and do hereby adopt the following articles of incorporation:

ARTICLE I - NAME

The name of this corporation shall be: BRITE-O ENTERPRISES, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The address of the principal office of this corporation shall be: 2681 West 74th Street, Hialeah, Florida 33016.

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.

ARTICLE IV - PURPOSE

The general purpose for which this corporation is organized is to transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue 1000 (One Thousand) shares of \$1.00 (One Dollar) par value common stock which shall be designated "Common Stock".

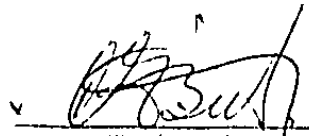
