The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Professional Service Corporation and Limited Liability Company Act.

**First:** The corporate name for the corporation (hereinafter called the "corporation") is:

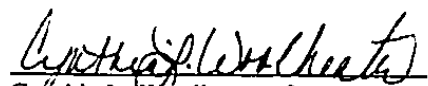

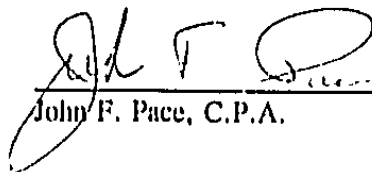
Eighth: The duration of the corporation shall be perpetual.
