ARTICLES OF INCORPORATION

The undersigned subscriber to those Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Suitutes.

ARTICLE 1 - NAME

The name of the Corporation is JC & L GRAPHIC GROUP, INC., (hereinafter, "Corporation").

ARTICLE 2 - PURPOSE OF CORPORATION

- 7.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is SEVEN THOUSAND FIVE HUNDRED (7,500) shares of common stock, outli chare having the per value of ONE DULLAR (71.00).
- 7.2 No holder of shares of stock of any class shall have any preemptive right to subscribe to or purchase any additional shares of any class, or any bonds or convertible occurities of any nature; provided, however, that the Board of Director(s) may, in authorizing the iocuance of shares of stock of any class, confor any preemptive right that the Board of Director(s) may deem advisable in connection with much insures.

ARTICLE 8 - SUB-CHAPTER S CORPORATION

- 8.3 Once the Corporation has elected to be an S Corporation, each share of stock issued by this Corporation shall contain the following legend:

"The shares of stock represented by this certificate cannot be transferred if such transfer would void the election of the Corporation to be taxed under Sub-Chapter S of the Internal Revenue Code of 1986, as amended."

ARTICLE 9 - POWERS OF CORPORATION

The Corporation shall have the same powers as an individual to do all things necessary or convenient to carry out its business and affairs, subject to any limitations or restrictions imposed by applicable law or these Articles of Incorporation.

ARTICLE 10 - TERM OF EXISTENCE
