ARTICLES OF INCORPORATION OF H.E.L.P. SOURCEBOOK, INC.

article i

CORPORATE NAME

The name of the corporation is H.E.L.P. SOURCEBOOK, INC. $\{D_{i,j}\}$

ARTICLE II DURATION

This corporation shall be perpetual existence commencing on the date of the filing of the Articles of Incorporation by the Department of State.

> ARTICLE III PURPOSE
