The undersigned, for the purpose of forming a corpodation underFLORIDA the Florida General Corporation Act hereby adopt the following articles of incorporation:

ARTICLE ONE NAME

The name of the corporation is SOUTHLAND SECURITY & INVESTIGATIONS, INC.
