

**ARTICLE I: NAME**

**ARTICLE II: NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is the marketing of apparel and other general merchandise associated with Daytona Beach, Florida, special events, and other related activities; and to engage in every and any aspect and phase of any and every lawful business, in the State of Florida and in all other states and countries.

**ARTICLE III: PRINCIPAL OFFICE**


