ARTICLES OF INCORPORATION OF IMPACT DISTRIBUTING & PUBLISHING, INC.

ARTICLE I CORPORATE NAME

The name of the corporation is IMPACT DISTRIBUTING & PUBLISHING, INC.

ARTICLE II DURATION

This corporation shall be perpetual existence commencing on the date of the filing of the Articles of Incorporation by the Department of State.

PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
