

The undersigned, acting as Incorporators of a corporation under The Florida Business Corporation Act, Chapter 607 Florida Statutes and pursuant to the Professional Service Corporation Act adopt the following Articles of Incorporation:

ARTICLE I

In no case shall these preemptive rights exist for a period in excess of 30 days from their first being offered to the shareholders.


ARTICLE VII
