The undersigned incorporator hereby forms a corporation under Chapter 607.0732, Florida Statutes, as follows:

Article I-Name

The name of the corporation shall be Schultz & Schultz, Inc., and the principal office and the mailing address of the corporation shall be 2338 Immokalee Road, #106, Naples, Florida 33942.

Article II-Nature of Business

The corporation is authorized to conduct any activities as are permitted under applicable Florida Statutes.
