## ARTICLES OF INCORPORATION

#### PREMIER HOLMES REAL ESTATE CORP.

#### ARTICLE I - NAME

The name of the corporation is Premier Holmes Real Estate Corp. (the "Corporation").

# ARTICLE II - PURPOSE

The Corporation is organized to transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
