**ARTICLES OF INCORPORATION  
OF  
SERVINET INTERNATIONAL, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**Name**

The name of the corporation is **SERVINET INTERNATIONAL, INC.** and its address is 800 Brickell Avenue, Suite 1109, Miami, Florida 33131.

**ARTICLE II**

**Duration**

The duration of the corporation shall be perpetual.

**ARTICLE III**

**Purposes**

The general purposes for which the corporation is organized are:

(1) To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

(2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE IV**

**Authorized Shares**

The aggregate number of shares which the corporation is

authorized to issue is 7,500. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.

#### ARTICLE V

##### Registered Office and Agent

#### ARTICLE VI

##### Directors


