The undersigned incorporator, for the purpose of forming a corporation pursuant to Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be: Young Management Services of Tampa, Inc.

ARTICLE II

The principal place of business and mailing address of the corporation shall be 522 D. Richlyne Street, Tampa, Florida 33617.

ARTICLE III

The duration of the corporation shall be perpetual unless dissolved according to law. This corporation shall become effective upon filing with the Secretary of State.

This corporation shall have no more than 1000 shares of common stock outstanding at any time.


