OF

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

**NAME OF CORPORATION**

The name of this corporation shall be **TRAINING RESOURCE GROUP, INC.**

**ARTICLE II**

**PRINCIPAL OFFICE**

The address of the principal place of business of this corporation in the State of Florida shall be 3408 N.W. 54th Lane, Gainesville, Florida 32653, and the mailing address of the corporation shall be Post Office Box 14345, Gainesville, Florida 32604. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

**ARTICLE III**
