# ARTICLE OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, being a natural person and competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

#### ARTICLE I

LA QUINTA PROPERTY MANAGEMENT INC. is the name of the corporation.

## ARTICLE II

This corporation shall have perpetual existence.

#### ARTICLE III

This corporation is organized for the purpose of engaging:

- a) To the rental of real property
- To consult, market, manage, and otherwise represent itself and b) others.
- to purchase, take, receive, lease or otherwise acquire, own, hold, c) improve use and otherwise deal in and with real or personal property or any interest therein, wherever situated.
- To sell, convey, mortgage, pledge, create a security interest in, d) lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.
- To lend money to, and use its credit to assist its officers and e) employees in accordance with S. 607.141.

- To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships or individuals.
- g) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchise and income.
- h) To lend money for its corporate purpose, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.

#### ARTICLE IV

This corporation has the power:

- a) To sue and be sued, complain and defend in its corporate name in all actions or proceedings.
- b) To conduct its business, carry on its operations, and have offices and exercise the power granted by its act within or without this state.
