The undersigned, CHARLES WALKER, subscriber to these Articles of Incorporation, being a natural person over the age of eighteen (18) years of age, competent to contract, hereby presents those Articles for the formation of a Corporation under the laws of the State of Florida.

# ARTICLE I. NAME OF CORPORATION

The name of the Corporation shall be VACATION BREAK OF CENTRAL FLORIDA, INC.

# ARTICLE II. BUSINESS OF CORPORATION

- 2.1 Specific Business: To engage in the business and professional practice of a telemarketing company; sell vacations to introduce people to timeshare.
- 2.2 General Business: This Corporation is organized for the purpose of transacting any and all lawful business, together with and in addition to those powers conferred by the laws of the State of Florida, and the principles of common law upon corporations organized and existing under and by virtue of the laws of Florida.
