#### ARTICLES OF INCORPORATION

The undersigned, a natural person competent to contract, for the purpose for forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

#### Article 1 - Name

The name of the corporation is:

#### ARTICLE 11 - DURATION

The term of existence of the corporation is perpetual.
