ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is: UNIFORMS PLUS CORPORATION

ARTICLE II-DURATION

This corporation is to exist perpetually. It shall commence its existence at the time of filing these Articles of Incorporation.
