The undersigned subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is SOLOMON & JOHNSON PROPERTIES, INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is: to acquire, by purchase or otherwise, own, possess, sell, mortgage, subdivide, develop or lease lands and premises, and to construct, lease or otherwise acquire, and develop, manage and maintain buildings for apartment houses, dwelling houses and business structures of all kinds for the accommodation of the public and of individuals, and to generally deal in any and all lands, improved and unimproved, dwelling houses and commercial buildings, and other buildings of any kind, and any and all other property of any and every kind or description, real, personal and mixed;

To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services of every class, kind and description;

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required:

To purchase the corporate assets of any other corporation and engage in the same or other character of business;

The name and post office address of the subscriber of these articles of incorporation is JOHN J. SULIK, 320 East Adams Street, Jacksonville, Florida 32202. The incorporator is specifically authorized by these Articles to designate the initial registered office and agent.

ARTICLE X. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 320 East Adams Street, Jacksonville, Florida 32202 and the name of the initial registered agent of this corporation at that address is JOHN J. SULIK.

ARTICLE XI. MISCELLANEOUS

This corporation shall have the right to amend or repeal any provision contained in these articles of incorporation and any right conferred upon the stockholders is subject to this provision.

employee the reasonable costs of settlement of any such action, suit, or proceeding, if it shall be found by a majority of a committee composed of the directors of this corporation not involved in the matter in controversy (whether or not a quorum) that it was to the interests of this corporation that such settlement be made and that such director, officer, or employee was not guilty of negligence or misconduct. Such indemnification or reimbursement shall not preclude such director, officer, or employee from exercising any rights to which he may be entitled under the by laws or otherwise.


