**ARTICLES OF INCORPORATION
OF

The undersigned does hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the state of Florida.

ARTICLE I

The name of the corporation shall be **SOUTH FLORIDA EYE INSTITUTE, INC.**

ARTICLE II

The principal place of business and mailing address of this corporation shall be 5333 North Dixie Highway, Fort Lauderdale, Florida 33334.

ARTICLE III

This corporation's existence shall be effective on the date of subscription of these Articles, and the corporation shall have perpetual existence.

The general purpose for which this corporation is organized is to transact any or all lawful business permitted under the laws of the state of Florida.


ARTICLE X


**CERTIFICATE OF DESIGNATION
